ACTIONS OR EVENTS OCCURRING SINCE THE LAST BOARD MEETING NEEDING TO BE ADDED TO THE RECORD:

Steve told the board that we received in the mail today a notice from the IRS that we are reinstated as a non-profit organization. Steve told the board that a compliance form must be filled in once a year so we keep our status.

Janice proposed that she will write out duty a duty statement for the next treasurer which will reflect the need for all necessary compliance forms to be filled out as required. Further that she will write out duty statements for all board members when time permits.

Janice told the board that because we are now up to date with the IRS, Steve was now in a position, as Vice President, to go to Rabobank so he can be instated as a person who can sign checks on behalf of SLO NightWriters. This has not been possible while we were in default of our nonprofit status. The board heard further that Janice had been granted the right to sign checks and do banking by Rabobank until we became active as a nonprofit organization again.

Steve told the board that he would be going to the bank with Janice to sort all the banking matters out.
