SIMPLY CLEAR MARKETING & MEDIA REPORT (Jeannie Hundertmark)

CONTEST DIRECTOR'S REPORT (acting: Janice Konstantinidis)

OLD BUSINESS

The board discussed procedures for bringing new volunteers onto the board, allowing certain functions to be performed by non-board members, and the handling of board emails and email voting.

A clarification was asked as to which emails/replies should be sent to multiple board members, and whether this treatment should be requested in the subject line of all emails. It was suggested that this designation would be optional depending on the relevance of the message.

A new and less costly SLONW PO box was rented, PO Box # 2986. New address stickers will be added to the existing brochures. Steve will print these. (See Treasurer report.)

PG&E has proposed that we become fiscal partners for the purpose of creating 24 high school scholarships to the Cuesta Writers Conference. This will involve no cost to SLONW, but the gifts will be in our name. The motion was moved, voted and adopted.

Dennis proposed the motion. Steve seconded it. The board was in favor.

It was proposed that SLONW should try out regular Facebook Boost advertising on social media for a period of six months at \$25 per month. This will be considered further. (See Social Media report.)
