Darryl: New outlets with writers:

The board heard a discussion about the possibility of three new outlets where members could have submissions published.

SLO NW Anthology to New York

I have sent the evaluation copy of our SLO NW collection from the Tolosa Press to the Barnes and Noble office in New York. I am not sure how long the decision will take but looking at the paperwork I feel confident that we will be approved for our local San Luis Obispo store. There is a section for “local authors” and we will be shelved there. After getting this approval, I want to start taking the book to other book stores, especially independents, and asking them to stock it. I am contemplating a small kiosk of about ten books for local gift stores, at least as an idea to proffer to shops in the area. Amount for which to sell the book etc. will come as a result of discussing this with other board members.

I would like to see us begin on our next collection but not be limited to that which was chosen for Simply Clear. I think we can provide a daily reader of six hundred words or one page or so per day. This will be a 365-page book filled with different forms of flash fiction etc. Format to be decided by membership. Should sell....

New Outlets for our Writers

I set up appointments with Information Press, Sandra Marshall, and New Times, Camilla Lanhan, and Janice and I met with both publishers. They are very positive about printing our pieces in their publications and will be sending us their guidelines so we may open this to our members. I met with Sandra Marshall again on the 1st of June and they are excited about our partnership with them. Both Editors/CEO's have expressed an interest in attending our meetings and addressing our members. This will be a large increase for our members to be published. Additionally, I plan to approach the Journal and then begin a search more regional and eventually national to find outlets for our writers. Eventually this may become a paid resource and I would like to meet with Terry Sanville and a few others in this respect. Always with the oversight of Janice and the BOD.

The board agreed that this was very positive for NightWriter members. Janice told the board that she would write to the membership about these offers while they were open.

Joining the State-wide Organization CWC

I whined like a school girl when I discovered we had not joined the state organization and therefore are the only club not listed on the Central Coast. I have begun making amends, with Janice's approval and will asking for assistance from another BOD member. We must have this affiliation if we are going to grow our club.

New Critique Group

With the assistance of Judy Guanera and Linda Lange, we have created a new type of critique group. It is a creative workshop with minimal attention given to the mechanical part of the writing and maximum effort to creativity and plot and/or story development. It will be a workshop available only to accepted members to bring their MS in and receive help in developing it to a fuller capacity. We are truly excited and will have had

our first meeting on the 5th of June, therefore I may be able to report the outcome of this first meeting. We are not taking other members yet until the guidelines are solidified and we are sure of the efficacy of this program. I wish to discuss this with Rosie as a possible change for her group.

High School, College Writing Contests

I have delayed this project for now while working on other projects for SLO NW but will look forward to working with Martha in July or August to get ready for the new school terms. I have noticed this program is endemic to other organizations and this only solidifies the need for it in ours. I may inquire as to methodology or this program, along with Martha, from other clubs.

Name Change

The name of the contest will be SLO Nightwriters Golden Quill Writing Contest. This will tie the organization to the contest for branding and significantly increased publicity exposure.

Timeframes

Call for Entries	June 15, 2017
Entry Deadline	September 15, 2017
First Round Judging	October 5, 2017
Final Round Judging	October 26, 2017
Awards Ceremony	November 14, 2017

Theme

The theme for the SLO Nightwriters Golden Quill Writing Contest will be *Liberation*. The use of that theme is mandatory for entrants to use in each category. There will not be any specific words required to include in the work.

Categories

Flash / Short Fiction	Up to 1,500 words
Poetry	Up to 40 lines
Creative Non-Fiction	Up to 1,500 words

Creative Non-Fiction was the most requested category in the feedback from entrants from past contests. Combining Short Fiction and Flash fiction will allow entrants to choose their preference in one category. Keeping the word count under 1,500 words will facilitate the expediency in which the judges will be able to score the entries.

Fees and Awards

The entry fee will be \$15.00 for each category.

Prizes will be awarded as follows for each category:

First Place	\$500
Second Place	\$250
Third Place	\$100

Total prizes \$2,550

Revenue

For the last two years, the writing contest has received approximately 300 entrants each year. Since 2014, the amount of entries has increased by 86%. The addition of a Creative Non-Fiction category may generate even further entrants, based on feedback of the last two years.

Projected Entry Fees \$4,500.00 - \$5,250.00

The contest is projected to realize at minimum \$1,000.00 after expenses, to return to the organization and membership.

Expenses

Total Awards \$3,500.00

Submittable

Advertising

The majority of advertising will be done via online social media outlets, and by direct email utilizing the extensive database gathered over the years of the contest. Free sites, such as blogs and Hope Clark's *Funds for Writers* will be used.

Publicity

A new logo has been designed
Posters will be made and disseminated county-wide with the help of the NW Board and members.

Trophies and Certificates

Nine trophies are required and 21 certificates for the finalists.

Advertising and Marketing

Targeted marketing will include local, national and international writing communities, markets and organizations.

Formal Press Releases will be submitted to major publications nationally.

Judges and Judging Parameters

The contest will continue to utilize "name" figures, well known to the writing community to further enhance legitimacy and desirability to entrants.

A scale of quantified judging criteria will be provided all judges, and the entrant will be provided these parameters as well.

The objective of each judge's evaluation is to determine one overall score from 0 to 50 for each entry (50 being the best possible score). Each submission will be checked for eligibility, inclusion of the theme, word and line limits, formatting and payment of entry fees prior to release to the judge.

The following criteria are to be used in evaluating each entry:

FLASH / SHORT FICTION

Use of the Theme

10 Points Possible

Originality and creativity in interpretation and incorporation of the theme is demonstrated.

Plot and Story

10 Points Possible

The plot is plausible and complete within the limits of the words allowed. The story is original and compelling. The story arc is logical and powerful.

Use of Language

10 Points Possible

Proper grammar is employed, strong quality of writing is demonstrated, language is mined for maximum expression, use of slang or cursing is not distracting, repeated words are minimized, word choices are creative and effective, and figurative language (metaphor and simile) are fresh and unique.

Emotional Impact

10 Points Possible

The story evokes emotion and allows for suspension of disbelief.

Narrative Voice and Content

10 Points Possible

The narrative voice is distinct and engaging and the point of view is effective and consistent. Any shifts in point of view are clear and intentional. The characters are well developed in the narrative and are unique and interesting. The dialogue is convincing and fresh and reveals the character(s). The speakers are identifiable. The description of the setting invokes an identifiable sense of place and the descriptions are vivid.

POETRY**Use of the Theme**

10 Points Possible

Originality and creativity in interpretation and incorporation of the theme is demonstrated.

Emotional Impact

10 Points Possible

The poem evokes emotion and allows for suspension of disbelief.

Message

10 Points Possible

The poem's message is unique, fresh, and moving.

Form and Flow

10 Points Possible

The poem is structured in a powerful way on the page.

Use of Language

10 Points Possible

The language employed is mined for maximum expression, word choices are creative and effective, figurative language (metaphor, simile etc.) are fresh and unique.

CREATIVE NON-FICTION

Use of the Theme

10 Points Possible

Originality and creativity in interpretation and incorporation of the theme is demonstrated.

Emotional Impact

10 Points Possible

The story resonates and is relatable to the reader, tapping into the human condition through the true story.

Use of Language

10 Points Possible

Proper grammar is employed, strong quality of writing is demonstrated, language is mined for maximum expression, use of slang or cursing is not distracting, repeated words are minimized, word choices are creative and effective, and figurative language (metaphor and simile) are fresh and unique.

Narrative Voice and Setting

10 Points Possible

The narrative voice is distinct and engaging and the point of view is effective and consistent. The characters are well developed in the narrative and are unique and interesting. The dialogue is convincing and clear and reveals the character(s). The description of the setting invokes an identifiable sense of place and the descriptions are vivid.

Factual Content

10 Points Possible

The events of the story are factual and believable. Hyperbole is not used.

SLO Nightwriters Golden Quill Writing Contest Contest Rules



Call For Entries: Entries accepted beginning June 15, 2017
Deadline: All entries and payment must be received by 11:59 p.m.
September 15, 2017

Theme: The theme of the 2017 Contest is ***LIBERATION***. All entries must depict this theme, originally interpreted. It is not necessary to include the word.

Categories:

Flash / Short Fiction: Up to 1,500 words
Poetry: Up to 40 lines
Creative Non-Fiction: Up to 1,500 words

Flash / Short Fiction must comprise a complete story within the word limit.

Creative Non-Fiction must be a true story and may include personal stories, memoir or personal essays. Stories selected as finalists may undergo a fact-checking process; documentation of sources is not required with submission, but may be requested.

Hyphenated words count as two words.

Contestant Eligibility: All writers from any locale are welcome to submit entries. Contest Advisory Committee and SLO Nightwriters Board members are not eligible. Contest Judges and Sponsor members are not eligible. Contestants may not win for the same story in more than one category. Entrants must be 18 years of age or older.

Entry Eligibility: Entries must be the original unpublished works of the authors and not previously accepted for publication. Entries that have previously won a

contest prize are not eligible. Non-published pieces written on-line that are not for sale, e.g. a blog site, are eligible.

Prizes: Prizes will be awarded as follows for each category:

First Place	\$500
Second Place	\$250
Third Place	\$100

Finalists: All top finalists will receive Finalist Certificates.

Submission, Fees and Payments:

Entries are only accepted via *Submittable*, a secure online submissions management tool. Applicants may enter more than one category, and submit more than one entry in any category. An entry fee must be paid for each entry. ***Please note once an entry has been submitted we are unable to accept revisions to that piece or issue refunds.*** If you want to revise your submission you may do so as a separate entry with payment of the new entry fee. Please rename the resubmission. Entries will not be returned. Payment of contest entry fees confirms you have read, understand and agree to the terms of all contest rules.

Entry Fee: \$15.00

Payment: Payments are accepted online via *Submittable*, at SLONWGoldenQuillWritingContest.com and SLONightwriters.org on the *Submit Here* link.

Deadline: The contest deadline is September 15, 2017, 11:59 p.m. All entries must be received prior to midnight on this date to be eligible. All entries must be paid in full by this date to be eligible.

Judging: Contest Judges will score each entry. Judging will be blind – the contestant’s name will not be included with the entry. A standardized quantitative scoring sheet will be used by each judge. The decisions of the judges are final.

Please reference the Contest Website at SLONightwritersGoldenQuill.com for more information on all judging criteria, and to see the judges’ profiles.

Formatting Instructions:

- All entries must follow this formatting. Submissions that do not comply with these instructions will be disqualified.
- All entries must be submitted electronically via *Submittable*.
- Use 12-point size Courier, Times New Roman or Ariel type font only

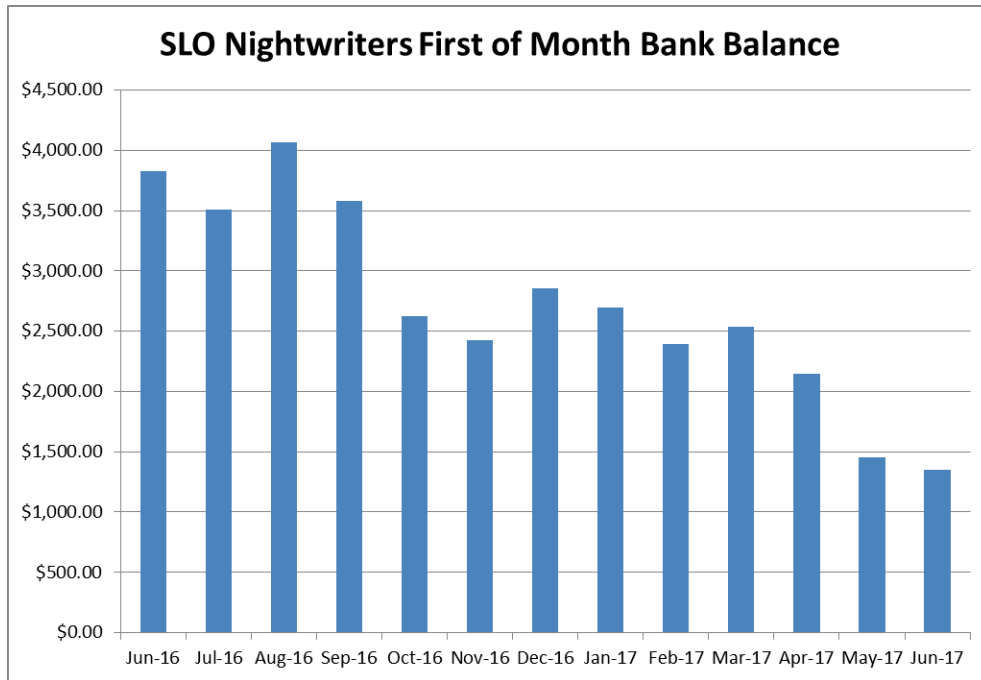
- Use Word .doc or .docx only.
- Flash/Short Fiction and Creative Non-Fiction must be double-spaced with a minimum of 1" margins all around, and include page numbers.
- Poems may be creatively spaced and formatted; include page numbers if needed
- The header of each page must include the title, entry category and word/line count only.
- ***No identifying information is to be placed on the entry itself.*** Do **NOT** upload a cover sheet with the entry

Notification: The top ten finalists and winning entrants will be notified via the email address provided. Other entrants will not be notified.

Announcements: Winners will be announced at the SLO Nightwriters meeting and Awards Ceremony November 14, 2017.

Publication: All rights belong to the authors. Winning contestants will be announced on the SLO Nightwriters Golden Quill Writers Contest and SLO Nightwriters websites. Contestants may have the opportunity to have their winning entry posted on line as well.

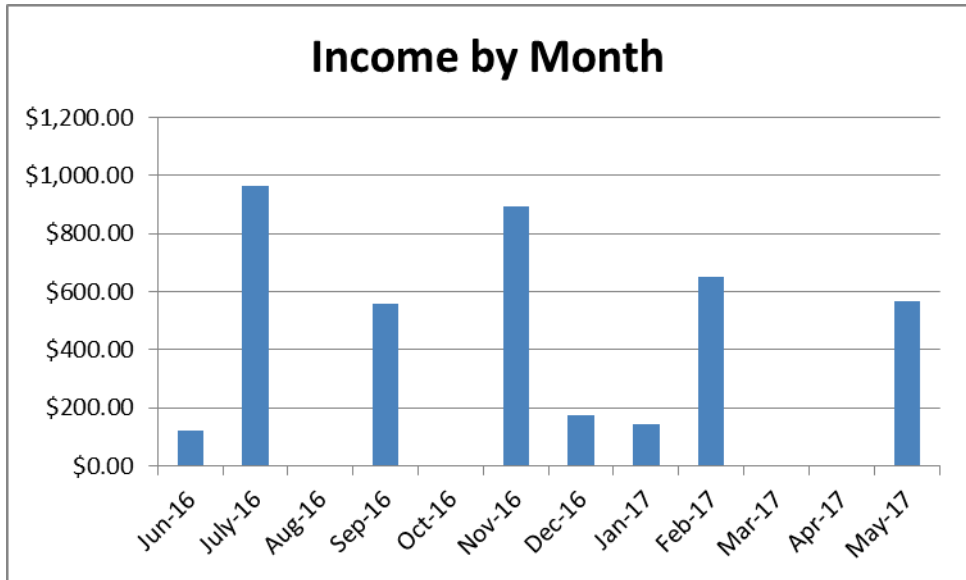
